The name of the corporation is:

ARTICLE II

The purpose of the corporation is to engage in the following business activities:

KNOWLEDGE, AND CO-ACTING WITH OUR NEIGHBORS.

CO-ACT, INC. SUPPORTS THE DEVELOPMENT OF GRASSROOTS COMMUNITIES WITH A SPIRIT OF CARE, RESPECT,

AND LOVE FOR ONE ANOTHER; TAKES COLLABORATIVE ACTIONS AND MAKES STRATEGIC PLANS THAT STRENGTHEN

OUR LOCAL COMMUNITIES AND GENERATES PROSPERITY AND WELL-BEING; NETWORKS ACTIVITIES FOR

COMMUNITY SELF SUFFICIENCY LOCALLY AND NATIONALLY TO CREATE A WEB OF STRENGTH, INFORMATION AND

REFORM.

CO-ACT MANAGES AND SUPPORTS COMMUNITY INITIATIVES THAT INCREASE COOPERATION, RELIEVE POVERTY

AND HUNGER, LOCAL AGRICULTURE, ALTERNATIVE ENERGY, AFFORDABLE HOUSING, PUBLIC TRANSPORTATION. AND

IMPROVE THE ENVIRONMENT. CO-ACT ALSO PROVIDES SERVICES ASSOCIATED WITH IMPLEMENTING THESE

INITIATIVES.

ARTICLE II.

ARTICLE III

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

CO-ACT'S MEMBERSHIP IS OPEN TO ANYONE WHO SUPPORTS ARTICLE II AND ATTENDS THE MEETINGS OF THE

COMPANY. AFTER ATTENDING NINE MEETINGS ONE IS OFFICIALLY A BOARD MEMBER OF CO-ACT AND MAINTAINING MEMBERSHIP REQUIRES ATTENDING 2/3'S OF THE MEETINGS HELD SINCE BECOMING A MEMBER. THE MEMBERS IN GOOD STANDING CONSTITUTE THE BOARD OF DIRECTORS AND ELECT THE

EXECUTIVE COMMITTEE. THE EXECUTIVE COMMITTEE CONSISTS OF THE PRESIDENTR, TREASURER AND

CLERK.

THE EXECUTIVE COMMITTEE MEMBERS SERVE ONE YEAR TERMS AND MAY BE RE-ELECTED ANNUALLY

INDEFINITELY. AT A REGULARLY SCHEDULED MEETING AT LEAST ONE MONTH, BUT NOT MORE THAN THREE

MONTHS, PRIOR TO THE ANNUAL BOARD MEETING, NOMINATIONS FOR THE EXECUTIVE COMMITTEE WILL BE

MADE AND ACCEPTED, TO CONSTITUTE THE SLATE TO BE VOTED ON AT THE ANNUAL BOARD MEETING. ONLY

MEMBERS IN GOOD STANDING ATTENDING THE ANNUAL BOARD MEETING MAY VOTE. THE BALLOT SHALL BE AN

INSTANT RUNOFF BALLOT ONE EACH FOR THE PRESIDENT, TREASURER, AND CLERK, AND THE VOTES ARE

BY RAISED HANDS AND SHALL BE COUNTED AT THE ANNUAL BOARD MEETING AND THE RESULTS ANNOUNCED

AND IMPLEMENTED.

AT EACH MEETING ATTENDANCE IS NOTED AND THESE RECORDS ARE THE BASIS FOR DETERMINING WHO IS AND

WHO IS NO LONGER A MEMBER ENTITLED TO VOTE AT THE ANNUAL BOARD MEETING.

OTHER CLASSES AND FORMS OF MEMBERSHIP WITH OR WITHOUT VOTING RIGHTS MAY BE FORMED BY A SIMPLE

MAJORITY VOTE OF THE EXECUTIVE COMMITTEE. THE AFFAIRS OF THE COMPANY ARE CONDUCTED BY THE

EXECUTIVE COMMITTEE WHICH MAY HIRE STAFF AND DETERMINE THEIR COMPENSATION, AND ORGANIZE

VOLUNTEERS WHO SERVE COMMUNITY INITIATIVES.

ARTICLE IV

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows: (*If there are no provisions state "NONE"*)

ARTICLE V
